

Terms of Agreement

- A deposit of \$100.00 per child must accompany application.
- Full payment must be received by **June 1, 2011**.
- No refunds will be issued after the first day of camp (see #5 below).
- Checks should be made payable to **Iona College Day Camps**.
- We also accept all major credit cards **for full payment only**.
- We offer a 10% discount for those who pay seven weeks in **Full**. Payment must be made by **June 1, 2011**. Tuition includes lunch, milk or juice, snacks, arts and crafts materials, T-shirt and entertainment.
- No credit card payment will be accepted during camp (only check, money order, and cash) for weekly payments
- All credit card payments must be done online - visit our link at **www.iona.edu/summercamp**

Conditions of Acceptance and Enrollment:

1. An Iona Day Camp Medical form must be completed and submitted by **June 15th, 2011**
2. The Iona College Day Camp also offers a ½ day program for Pre 1 only. Pre 1 is for children who are 5 years old or will be 5 by August 31. There will be no exceptions.
3. The camp will not allow usage of cell phones, video games or CD players during camp hours nor will be responsible for the items mentioned above if brought to camp.
4. Campers, parents and /or guardians agree to abide by camp rules and regulations.
5. **It is understood no part of the tuition fee, or deposit, will be refunded after the first day of camp. If a camper is absent due to illness or accident, as certified by a physician's letter, for 5 consecutive camp days during the camp session, a pro-rated refund will be made for every day thereafter.**
6. It is understood that camp days may not be substituted due to illness or any other absence. This is strictly followed.
7. I give permission for my child to participate in all camp-related activities.
8. In the event that I cannot be reached by phone in an emergency, I hereby give permission to my family physician, any local physician or hospital and to Iona College Day Camp to administer emergency treatment to my child.
9. It is understood all photography, videos and interviews taken at camp may be used for promotional/advertising purposes.
10. Camp hours are Monday-Friday from 9am-4pm. If a child is dropped off between 8 and 8:30 or picked up after 4:30 there will be a \$10.00 charge for every fifteen minutes. This charge will be added on to your bill.
11. In the event that this agreement is executed by one parent, the signer acknowledges that he/she is also acting as agent of the other parent with the authority to enroll the child at camp and to execute this agreement on his or her behalf.
12. This contract constitutes the full understanding of the parties hereto and no change, modification or waiver of any of the terms shall be effective unless in writing and signed by both parties.
13. If a child is disciplined 3 times, the camp reserves the right to dismiss the child for inappropriate behavior with NO refund.
